**11:30**      **CA Highways Can't Grow Anymore - Now What?**

During the pandemic, California enacted policies that could represent the most significant climate-change weapon yet: CAPTI. In putting the brakes on most highway expansions, the Climate Action Plan for Transportation Infrastructure represents a radical shift. But old habits die hard, as evidenced by Fresno's recent bid to build a highway interchange. A coalition of grassroots groups is fighting the expansion using the new policy as a tool to demand more community-serving infrastructure. Similar efforts are brewing in San Bernardino. Join us to hear from the state's leading expert on CAPTI, and from advocates working to turn the no-new-highways moment into more equitable infrastructure options for communities throughout the state.

**9:15am**      **How to Show Up in a Moment of Massive Money: Pulling Down the Funds**

There is both excitement and anxiety about how to ensure frontline communities receive their fair share of the historic infrastructure funding from programs such as the IJA. This session will highlight examples of how funders and NGOs have successfully leveraged funding from the federal and state government and hear about lessons they are learning. This panel will tell the story of the Irvine-funded Edge Collaborative in Stockton, which recently won \$16 M in federal funds for EV car sharing for public housing with a workforce component; we'll hear from Resources Legacy Fund about a joint effort that succeeded in leveraging \$50 M from the EPA that will now be regranted throughout California, Arizona and Nevada; and we'll learn how the San Diego Community Foundation served as a regional hub, bringing together community partners who won \$26 M from the state's Transformative Climate Communities program.
